Latham moved with Watts seconding, to adopt Resolution 2022-48, WHEREAS, on this 17th day of May, 2022, the Board of Supervisors of Cerro Gordo County, Iowa. held a public hearing at 10:05 a.m. to consider an amendment to the fiscal year 2021/2022 budget; and, WHEREAS, there was present a quorum as required by law; and, WHEREAS, after hearing all taxpayers be heard, the Board of Supervisors took up the budget amendment for final consideration and determined that said budget amendment be approved. THERE-FORE, BE IT RESOLVED, that the Board of Supervisors of Cerro Gordo County does hereby approve the fiscal year 2021/2022 budget amendment. Motion passed.

Latham moved with Watts seconding, to adopt Resolution 2022-49, WHEREAS, it is desired to make supplemental appropriations, in accordance with Section 331.434(6) of the Code of Iowa; and, NOW THEREFORE, Be It Resolved by the Board of Supervisors of Cerro Gordo County, as follows: Section 1. The amounts itemized

by account number on the attached schedule are hereby appropriated from the resources of each fund so itemized. (The following amounts are for FY2022). Section 2. Subject to the provi-

sions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2021.

Section 3. In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amounts appropriated pursuant to this resolution. For purposes of this section, the use of holding accounts shall be deemed an appropriate mechanism for the allocation of expenses. Appropriations made to such accounts shall be deemed as sufficient authority for department heads to expend such resources. and will be allocated to expenditure accounts in the same manner as the related expenditures are allocated.

Section 4. If at any time during the 2021-2022 budget year the auditor shall ascertain that the available resources of a fund for that year will be less than said fund's total appropriations, the Auditor shall immediately so inform the board and recommend appropriate corrective action.

Section 5. The auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which accounts shall indicate the amount of the appropriation, the amounts charged thereto, and the unencumbered balance. The auditor shall report the status of such accounts to the applicable departments and officers monthly during the 2021-2022 budget year. Supplemental
